Home Tuition – Safeguarding and Child Protection Policy | TCC



Introduction

At the **Training & Computing Consultants (TCC)**, we provide home tuition as one of our many services. When doing so, our highest priority is the safety and well-being of all persons receiving such tuition. This **Safeguarding Policy** outlines the measures we take to 1) protect tutees and tutors from harm; 2) ensure that a secure learning environment prevails and 3) promote a culture of respect, professionalism and transparency.

1) Purpose of Our Safeguarding Policy

Our home tuition safeguarding policy is designed to:

- a) Protect tutees, as well as tutors from abuse, neglect, or harm during tuition sessions.
- b) Ensure a clear framework for identifying and addressing child protection concerns.
- c) Promote professional conduct, clear boundaries and a safe environment for learning.

2) Scope of This Safeguarding Policy

This policy applies to all home tuition services offered by TCC, whether conducted:

- In the tutee's home.
- At another designated location approved by the parent or guardian.
- During online tutoring sessions, where relevant.

3) Key Definitions

- a) Child: Any person under the age of 18.
- b) Tutee: Any person being instructed by a tutor.
- c) **Abuse**: Any form of physical, emotional, or sexual conduct that results in actual or potential harm.

4) Principles

- a) Best Interests of the tutee: The welfare of the tutee is paramount.
- b) **Zero Tolerance:** Any form of abuse, harm, or inappropriate behaviour is not tolerated.
- c) **Confidentiality:** Information regarding tutees and their families will be handled sensitively and shared only when necessary to protect the child.



Code of Conduct for Tutors

All TCC tutors adhere to a strict code of conduct to create a safe and respectful environment:

1) Professionalism and Respect:

- a) Maintain a caring and professional relationship with children and their families.
- b) Tutors must conduct themselves using appropriate language and behaviour at all times.

2) Transparency and Accountability:

- a) Deliver lessons in visible, open spaces—preferably in areas where parents or guardians can observe.
- b) Avoid private or secluded settings.

3) No Physical Contact:

- a) Refrain from physical contact with tutees unless necessary (e.g., preventing harm).
- b) Respect personal boundaries at all times.

4) Safe Digital Interactions:

- a) For online tuition, use secure platforms and maintain professional communication.
- b) Ensure parents or guardians are aware of virtual lesson times and content.

5) Safeguarding Measures:

- a) **Background Checks:** We will ensure that DBS checks are carried out on all TCC tutors and will provide evidence of such when requested.
- b) Training: We stay informed about child protection principles and best practices.
- c) **Parental Presence:** Parents or guardians are encouraged to remain nearby during sessions, especially for younger children.
- d) **Environment:** Tuition will take place in a safe, well-lit and comfortable environment.

6) Responding to Concerns:

If TCC tutors have any concerns regarding the safety or welfare of a child, they will:

- a) Document the concern in detail, including dates, times and any observations.
- b) Discuss the concern with the parent or guardian, unless this may place the child at further risk.
- c) Report the concern to appropriate authorities if there is evidence of abuse or neglect, in line with local legal requirements.



7) Communication with Parents/Guardians:

We will maintain open and honest communication with parents or guardians, ensuring they are aware of the child's progress and any concerns that may arise.

8) Review and Updates:

This policy will be reviewed annually, or as needed to ensure it remains current and effective.

Updates will reflect changes in legal requirements or best practices in child protection.
